Composite Decking & Fencing 10 Year Warranty

Warranty

Arbour Landscape Solutions (hereinafter "ALS") warrants that for a period of 10 (ten) years, under normal use, ALS warrants that ALS wood plastic composite products will not split, splinter, rot or twist and it will be free from any material or manufacturing defect.

The limited warranty of 10 years is from the date of purchase, if any products are defective during this 10-year period then ALS shall replace the products at no charge.

This warranty shall not cover and ALS shall not be responsible for costs and expenses incurred with respect to the removal of defective ALS products or the installation of replacement materials, including but not limited to labour and freight.

To make a claim under this limited warranty, the customer will send to ALS, within the warranty period referred to above, a description of the claimed defect (including photos of the defect) and proof of purchase.

This Warranty covers the wood plastic composite products the clips and fixing system provided by ALS.

Limitations

ALS does not warrant against and is not responsible for, and no implied warranty shall be deemed to cover, any condition attributable to:

- **1.** Improper installation of ALS products and/or failure to abide by ALS installation guidelines, including but not limited to improper gapping.
- **2.** Use of ALS products beyond normal use, or in an application not recommended by ALS guidelines and local building codes.
- **3.** Movement, distortion, collapse or settling of the ground or the supporting structure on which ALS products are installed.
- **4.** Any act of God (including and not limited to flooding, hurricane, earthquake, lightning, etc.), environmental condition (such as air pollution, mould, mildew, etc.), staining from foreign substances (such as dirt, grease, oil, etc.), or normal weathering (defined as exposure to sunlight, weather and atmosphere which will cause any coloured surface to gradually fade, flake, chalk, or accumulate dirt or stains).

- **6.** Improper handling, storage, abuse or neglect of ALS products by Purchaser, the transferee or third parties.

This warranty may not be altered or amended except in a written instrument signed by ALS and the Customer.

Under no circumstances will ALS be liable for special, incidental or consequential damages, whether such damages are sought in contract, in tort (including but not limited to negligence and strict liability) or otherwise, and ALS's liability with respect to defective products shall in no event exceed the replacement of such products.
